Municipal entities and special districts can own a solar energy system and finance 100% of project costs using Tax-Exempt Lease Purchase (TELP). The TELP financing structure can incorporate direct payment from the IRS for qualifying clean energy projects using the new Section 6417 rules under the Inflation Reduction Act (IRA).
